Main case

In the light of order dated 15.02.2023, an enquiry report dated 20.02.2023 has been placed on record, which has been countered today and on perusal of the conclusion recorded therein, no doubt has been found by the Committee on the calculations of the candidates, who possess IME qualification from Mumbai.

In the light of the above, as was the pre-requisite stipulations in the order dated 15.02.2023, the writ petition stands disposed of. Although the petitioners will be at liberty to challenge the enquiry report dated 20.02.2023 before the appropriate Court of law.

Being bound by the order dated 15.02.2023, an exemplary costs of Rs.50,000/- be paid by the petitioners, which shall be subject to the final outcome of litigation, if any, initiated by the petitioners, confined to the challenge to the enquiry report dated 20.02.2023.
