By this common order, four writ petitions, the details of which have been given in the heading, are being disposed of as all the petitions involve the same question of law on similar facts.

#### **CM-13875-CWP-2016**

As prayed for, the application is allowed.

#### CWP-21874-2015 and other connected cases

Learned senior counsel for the petitioner submits that the petitioner competed for the post of PGT Hindi as advertised by the respondents vide Advertisement No.6 of 2006 but certain grievance of the petitioner exist qua the said selection as the written examination was conducted in a manner not envisaged under law. Learned senior counsel for the petitioner further submits that in the written examination, there were certain questions, which raised doubt qua their correct answers as depicted in the answer key and despite the fact that the petitioner raised objection qua those very questions but as those were again sent to the Chief Examiner, none of the said objections were accepted by the respondents, which

grievance exist even as of now.

Learned senior counsel further submits that though the selection process has already attained finality and even the candidates have already been appointed but the petitioner's grievance exist even as of now and the petitioner intends to approach the respondent-Commission raising a grievance that the objections qua certain questions, which have not been accepted by the Chief Examiner, be sent to another Expert for independent opinion and the respondent-Commission may kindly be directed to decide the said grievance in a time bound manner by passing an appropriate speaking order.

Learned senior counsel for the petitioner submits that the representation has already been filed by the petitioner, a copy of which has been attached with the CM-13875-CWP-2016, which may be read as representation on behalf of the petitioner to be decided.

Learned State counsel submits that in case, any representation is filed by the petitioner(s) raising any grievance or if already filed, the same will be dealt with in accordance with law and terms and conditions of the advertisement and appropriate order on the prayer of the petitioner(s) will be passed within a period of eight weeks of the receipt of any such representation and in case, after the decision, the petitioner(s) are found entitled for any relief, the same will also be extended to the petitioner(s) without any further delay.

Learned counsel for the petitioner(s) submits that keeping in view the statement of the learned State counsel, the present petitions may kindly be disposed of having been not pressed any further.
